# **CEnvP Scheme Certifies First Social Impact Assessment Specialist**

In a global first, the Certified Environmental Practitioner (CEnvP) Scheme this month certified its first specialist in Social Impact Assessment (SIA).

The CEnvP Scheme and its Specialist Environmental Advisory Committee (SEAC) for SIA is delighted to announce that **Dr. Richard Parsons** has been awarded the title of **Certified Environmental Practitioner -Social Impact Assessment Specialist**. Richard currently leads the Social Value and Engagement team at SMEC, and previously led the technical development and implementation of the SIA guidelines with NSW Department of Planning and Environment.

In late 2022, and in response to industry and practitioner demand, the CEnvP-SIA specialist certification was launched to recognise the extensive professional experience, skills, and ethical conduct of eligible SIA practitioners.
